

## 2. Carbon neutral:

RenewablePLUS is carbon neutral. The CO<sub>2</sub>-emissions, which occur during the construction and operation of the power plants, are offset using certificates from climate protection projects. Thus, RenewablePLUS actually means zero CO<sub>2</sub>. The Verified Emission Reductions used for the carbon neutralisation of RenewablePLUS are derived from ÖkoPLUS-projects that adhere to high standards for environmental and social sustainability.

## 3. Transparency and credibility:

The features of the RenewablePLUS label are firmly fixed in its catalogue of criteria (version 1.1), which is kept publicly and transparently. In order to guarantee that these criteria are upheld, an annual review, audit and certification process is performed by the TÜV Rheinland Energy GmbH, an independent auditor.

## 4. Simultaneity on a monthly basis:

Our label RenewablePLUS includes simultaneity on a monthly basis as a key feature. Which means that you can be sure that the production of your renewable energy does not just take place in few weeks of the year, but is simultaneously produced every single month of the year<sup>3</sup>.

## Digression : Recognised Guarantees of Origin:

RenewablePLUS is based on recognised GoOs tracking the production of electricity from renewable energy sources. All suppliers of electricity are obliged to label their electricity within the documentation of electricity origin and to validate and void their Guarantees of Origin for the energy gained from renewable sources<sup>4</sup>.

<sup>4</sup> In our home country Germany for example, the use of Guarantees of Origin for Renewable Energy in is mandatory since 2013. These are registered, validated and cancelled at the national register of Guarantees of Origin (HKNR) at the Federal Environment Office (UBA). Other European countries have similar institutions.





